# NOTICE OF MEETING TO VOTE ON TAX RATE

A tax rate of \$ .52312 per \$100 valuation has been proposed by the governing body of Wheeler County

The no-new-revenue tax rate is the tax rate for the 2020 tax year that will raise the same amount of property tax revenue for Wheeler County from the same properties in both the 2019 tax year and the 2020 tax year.

The voter-approval rate is the highest tax rate that Wheeler County may adopt without holding an election to seek voter approval of the rate.
